

Toledo Memorial Park's Driven by Courage Car Raffle Rules

Toledo Memorial Park and Mausoleum Association of Northwest Ohio (d.b.a. Toledo Memorial Park - "TMP") is incorporated as a 501 (c) (13) nonprofit corporation under the laws of the State of Ohio for the primary purpose of operating a cemetery in Sylvania, Ohio.

The Toledo Memorial Park Driven by Courage Car Raffle ("Raffle") is conducted for the purpose of generating construction and ongoing maintenance funds for The 911 First Responders Last Call Memorial of TMP.

All times are Eastern Time Zone.

1. ELIGIBILITY. Each entrant, by entering the Raffle, agrees to abide by all of the rules and conditions contained herein, as well as all applicable local, state and federal laws and regulations, and further agrees to release TMP and its directors, advisors, officers, agents and employees from any and all liability with respect to all aspects of the Raffle including, but not limited to, the selection process. The Raffle is open to any eligible person residing in any place where the Raffle is not prohibited by state, local or other laws. Employees of TMP, their immediate family members, members of TMP's Board of Directors, Council of Advisors, and their immediate family members, and agents and prize suppliers and their immediate family members are not eligible to participate in the Raffle. "Immediate Family" members are defined as someone's spouse, parents and grandparents, children and grandchildren, brothers and sisters, mother-in-law and father-in-law, brothers-in-law and sisters-in-law, daughters-in-law and sons-in law. Adopted, half, and step-members are also included in immediate family. Entrants must be 18 years of age or older.

2. CERTIFICATE PURCHASE. The cost to purchase a single entry ("Certificate") for the Raffle is \$100.00 (U.S. Funds only) and is not tax deductible. Any entrant may purchase more than one Certificate. An entrant can enter the Raffle by purchasing a Certificate in-person at TMP's offices located at 6382 Monroe St. Sylvania, Ohio between 8:30 a.m. and 4:30 p.m. Monday through Friday.

Certificate payment can be made by cash (U.S. Funds only) or money order. TMP and its staff, agents, Board, vendors, volunteers, and members assume no liability for lost, late, misdirected, mutilated, incomplete, illegible, undelivered entries or entries without proper payment received, which entries shall be deemed invalid and shall be immediately disqualified.

If an entrant's payment is dishonored by a bank for any reason, such entrant's Certificate will be declared invalid unless full and satisfactory payment is made prior to the Raffle drawing. Any dishonored payment will be considered an invalid entry, and TMP will endeavor to notify the entrant by mail. Completed entry certificate forms must be in the possession of TMP by 3:30 p.m. on Sunday, September 10, 2017, or before 999 valid Certificates are sold, whichever comes first, to be eligible for the Raffle.

All certificate forms will be handled and recorded on a first come, first served basis. Any certificate forms and payments (including payments previously dishonored) received after closure of the Raffle will be returned to the entrant. Upon receipt of a properly completed registration form and valid payment, a Certificate with an assigned raffle number will be issued. The Certificate shall be issued to the entrant upon purchase. All purchases of Raffle Certificates are non-refundable after an entry has been included in any prize drawing, unless the Raffle has been cancelled under the terms listed in Section 6 below.

3. PRIZES. If the Car Raffle is not modified or canceled under the terms of Section 6 of the rules, TMP will award one (1) prize totaling \$53,790.00 to the lucky winner.

In the event that a winning Certificate has more than one (1) name listed, TMP will award the prize to the first name listed on the entry. The records of TMP shall be deemed correct if there is a discrepancy or dispute. TMP is not responsible for resolving any disputes that may arise from different individuals listed on a valid Certificate. Any and all prizes inure only to the designated winner and may not be transferred, sold or otherwise made available to another party.

The winner of the 2017 Chevy Silverado 1500 Z71 4X4 LTZ Crew Luxury Car, is responsible for Federal and any other tax liabilities. The 2017 Chevy Silverado 1500 Z71 4X4 LTZ Crew Luxury Car model is more fully described at Chevy's website.

The Chevy Silverado is provided by Dave White Chevrolet, Sylvania, Ohio. The Winner of the 2017 Chevy Silverado 1500 Z71 4X4 LTZ Crew Luxury Car is fully responsible for costs associated with title, licensing, registration, transportation, delivery and other fees, and local, state and federal taxes, including without limitation all applicable sales, use, luxury, income and special taxes, as well as all-risk motor vehicle insurance, proof of which must be provided in writing prior to delivery.

Options may be added at winner's sole expense. The price for winner's selected options will be based on the Manufacturer's Suggested Retail Price (MSRP), which will be provided by the dealership. The winner will work directly with Dave White Chevrolet to secure any desired options beyond those available on the base model. TMP will not act as agent on behalf of the winner to secure the desired options. The awarding of the 2017 Chevy Silverado 1500 Z71 4X4 LTZ Crew Luxury Car is subject to availability at Dave White Chevrolet. Given that this model may be in high demand, delivery may take time. If the 2017 Chevy Silverado 1500 Z71 4X4 LTZ Crew Luxury Car is unavailable, TMP, at its sole discretion, may substitute another vehicle of similar value. The choice of the substituted, replacement vehicle is solely at TMP's discretion.

The winner must take delivery of the vehicle at Dave White Chevrolet, a Chevy dealership whose address is 5880 Monroe Street in Sylvania, Ohio 43560. The winner, at his or her sole expense, may choose to have the vehicle shipped to another location for final delivery. This delivery fee is separate and distinct from the manufacturer's Destination Fee. The winner is responsible for making any and all such arrangements for final delivery of the vehicle. TMP will not act as agent on behalf of the winner in arranging final delivery. Timing of the delivery of the vehicle to the dealership is at the discretion of Dave White Chevrolet.

4. WINNING CHANCES. A maximum of 999 Certificates will be sold. Each Certificate represents one chance to win. You may enter as many times as you like. Chances of winning a prize depend on the number of eligible Certificates sold. Overall, an entrant with one ticket has approximately a 1 in 999 chance of winning at the onset of the raffle. If 999 certificates are sold, your chance of winning is 1 in 999 with one certificate purchased. The actual odds of winning a prize in any drawing are dependent on the number of eligible Certificates sold and available for the drawing.

5. DRAWINGS. Subject to Section 6, Modification or Cancellation of Drawing, winners will be determined by random drawing of all the eligible Certificates received by the entry deadlines.

Winners need not be present to win.

The name of the winner will be posted on TMP's website (www.toledomemorialpark.com/diven-by-courage) at or before Tuesday, September 12, 2017 by 9:00 a.m. for all valid certificates received by 3:30 p.m. on Sunday, September 10, 2017.

The Drawing will be available to watch online at TMP's Facebook page (www.facebook.com/ToledoMemorialPark) at or before 4:00 p.m. on Sunday, September 10, 2017. The winner's name also will be posted on TMP's website.

6. MODIFICATION OR CANCELLATION OF DRAWING. TMP reserves the sole right to cancel or modify the Raffle. In the event that a Raffle is canceled or modified, it will be announced online at TMP's website.

If 999 certificates are not sold by 3:30 p.m. on Sunday, September 10, 2017 TMP, at its sole option, may modify the Raffle by withdrawing the vehicle and split the remaining net proceeds (income less expenses) equally between the winner and TMP.

If all available certificates are sold before the scheduled drawing date (i.e., TMP has determined that the raffle is "sold out"), TMP reserves the right to end the raffle early by holding all remaining drawings, including the Grand Prize Drawing, at a date earlier than the scheduled final drawing date. This puts the winnings in the hands of winners sooner.

7. WINNERS. Winners will be notified by phone, e-mail or by mail based on the information received on the registration form. Winners' names, city and state will be available to all media and will be available at the offices of TMP and listed on TMP's website. Winning entrants agree to allow TMP to use their names, likeness, and any statements made by them regarding the prize for advertising or publicity purposes without compensation. Winners may be required to complete and return an affidavit of eligibility and/or liability release and required tax forms. A winner's failure to do so if requested or if one otherwise fails to comply by these rules and/or to make arrangements to claim his or her prize within ninety (90) days of a drawing notification will void that entry. If a winner cannot be contacted or located by reasonable means after a period of ninety (90) days from the date of any Raffle drawing, the prize will be deemed forfeit and shall be considered to have been donated to TMP for its charitable purposes.

8. AWARDING OF PRIZES. While more than one name may be listed on a registration form, only the first name listed shall be deemed to be the entrant. A social security number must be provided, and it must be that of the entrant. Delivery or payment of any prize shall be made solely to the entrant. All prizes inure only to the designated winning entrant and that person may not transfer, sell or otherwise make the prize available to another party. The entrant of a multiple party entry has the sole and exclusive responsibility to allocate any such prize among the participants in a multiple party entry. TMP bears no responsibility for such matters.

9. AUTHORITY AND CONTROL. The decision of TMP shall be final in all matters concerning the Raffle. The Raffle is subject to the laws of the State of Ohio. The Raffle is void where prohibited by law. TMP is not responsible for any errors or omissions in the Raffle's advertising and/or any printed, broadcast, or Internet-provided materials or information. TMP reserves the right to modify and/or amend the Raffle rules at any time. If a material change to the rules is made after the start of the Raffle, notice of the material change will be made within twenty-four (24) hours of the change online at TMP's website (www.toledomemorialpark.com/diven-by-courage). A material change is defined as one that defines the operation of the Raffle and which affects participation therein. A material change can include, but is not limited to: how to enter or participate in the raffle; eligibility restrictions; entry deadline dates; whether prizes can be won; when prizes can be won; the extent, nature and value of prizes; basis for valuation of prizes; time and means of selection of winners; and/or cancellation procedures.
